الشروط الخاصة التسلسل

- 1 - Goods Must Be Dispatched/Delivered Under The Same Storage Conditions That Comply With Their Nature.
- 2 - the quoted item should be FDA and CE approved
- 3 - THE DELIVERED GOODS MUST BE STAMPED, PRINTED OR LABELLED:-
"SOLD TO DRMS". WITH DURABLE INK
- 4 - ALL PARCELS, PACKAGES AND RELATIVE DOCUMENTS TO BE MARKED:-
DRMS TENDER NO. P100-2017-6 GHQ JORDAN ARMED FORCES
AMMAN - JORDAN
- 5 - Quoted Item Should Be Previously Approved By DRMS
- 6 - PROMPT DELIVERY ON ONE CONSIGNMENT
- 7 - Samples of the quoted items must be submitted along with the offers, showing the same serial no., item no., as per tender documents specifications for purchase and receipt purposes. RMS with this respect reserves the right to reject offers not in compliance with this term.
- 8 - Pricing must include services of sale, shipment, transportation, delivery from port to site or to Main Medical Stores.

التسلسل الشروط الخاصة

- 9 – Custom clearance of goods shall be the responsibility of the Jordanian Armed Forces (JAF), however, suppliers shall bear all costs incurred by handling charges and any demurrage charges or extra expenses incurred by the port's corporation or QAIA (including expenses caused by delay in presenting the necessary shipment documents for either clearing or transporting the goods to the required location mentioned in the final order, delivery note issuing charges, unloading charges, local shipping charges, etc.). The supplier is also responsible for providing of all relevant shipping documents ,together with the delivery order(s).
- 10 – DRMS has the right to exchange any size of the awarded items with any other size , such exchange should be within one week after receipt of our written request , any delay will impose penalties as per GHQ/RMS regulations
- 11 – GOODS are to be freshly prepared on dispatch & should have at least 2/3 of its shelf life upon receipt . Any item carrying less than 2/3 of its shelf upon receipt should be accompanied with a confirmation that you accept to replace any remaining unused quantities at your expenses after the expiry date . Said confirmation is subject to the approval of the director of the Royal Medical Services and will incur a fine . which will be decided later by DRMS according to the loss that this discrepancy with terms of the tender has caused .
- 12 – description of goods, expiry date , lot no. as well as manufacturing date must be mentioned clearly on the outer and inner packs
