 - d. The DRMS with this respect reserve the right to reject any item not in compliance with this term.

الشروط الخاصة

- a. The companies are required to comply with the latest requirements 15 of JFDA for each ordered batch of vaccines, serums and products of human origin.
 - b. Directorate of the Royal Medical Services (DRMS) will not be responsible for any cause leading to rejection or delay in testing due to missing of any of the needed requirements.
- The companies are required to comply with the specifications of the 16 required items exactly, if there is any deviation from the specification, the word "Alternative" should be mentioned clearly.
- a. The acceptance of all items is subjected to the approval of the 17 Quality Assurance Laboratory of the JFDA or any other laboratory the recieving committee consider except for item 5 it should be subjected to the approval of Quality Assurance of the Royal Scientific Society Laboratory or the Ministry of Agriculture laboratories and the company should provide the laboratory with reference standard for product analysis and product description to test the efficacy of the product , all inspection charges will be on local agent expences.
 - b. Any rejected lot should be returned back to the supplier at his own expense and replacement and/or compensation should be delivered or effected in a period not exceeding 30 days from the written notification by the Directorate of the Royal Medical Services.

- 24 * Early delivery/shipment should only be done by written approval of (DRMS)
 - * Early delivery/shipment before due time for each consignment will impose on you a penalty as follows:
 - $-\left(0.0007\right)$ of the value of the early delivered/shipped quantity per each early day for the first 45 days.
 - $^-\,(0.0014)$ of the value of the early delivered/shipped quantity per each early day (for the whole early period) if the early period exceeds 45days until 90 days.
 - $^-\,(0.0021)$ of the value of the early delivered/shipped quantity per each early day (for the whole early period) if the early period exceeds 90 days until 120 days.

(Minimum penalty not less than 20JD)

- In addition to the above mentioned penalty a confirmation to replace any remaining unused quantity after the expiry date (for the early delivered/shipped quantity) by supplier/local agent in Jordan (at their expenses) should be accompanied unless the early delivery/shipment occured upon (DRMS) request.
- Early (shipping /delivery)period will not be considered when calculating the requested reserved shelf life since it will be considered according to shelf life reserved at time of (delivery /shipment) required in the order sheet.

In case the product failed the test, RMS has the right to exchange all the awarded quantity or to have a full refund in addition to a penalty that will be decided later by RMS according to the loss that occured.

The contractor is responsible to provide DRMS immediately with the rejecting or cancelling document.

 - b) Under Registration or non registered medications should be previously evaluated and approved by DRMS & supplied with newly issued Free Sale Certificate (FSC). Said certificate should be:
 * accepted and approved from JFDA and stating clearly that the drug is " Freely sold in the country of origin" & should be submitted along with the Quotation / documents.
 - 29 For registered items prices should be in compliance with export price granted by JFDA, In case of export price reduction after tender endorsement and final notification, a compensation in favour of JAF/RMS will take place either as value or goods according to RMS needs for not delivered quantities of tender P28/2019/F at date of JFDA price reduction.
 - 30 Replacement of any item previously accompanied with a confirmation should be affected within (3 months) from the date of the written notification with the same terms and conditions of the award unless otherwise requested by RMS according to their stocks and needs.
