- **Special Terms:**

- 1- Country of origin : USA, Canada , Japan , UK, Sweden, Finland , Denmark , Switzerland , Belgium, Germany, France , Netherland , Spain, Norway , Italy , Ireland, Austria , Newzealand , Australia.
- 2- A copy of (CE OR FDA OR TUV Certificate, etc) is to be submitted along with the awarded items and should be certified by (Jordan Food and Drug Administration).
- 3- The Supplier should be committed to exchange the awarded item with any other size according to RMS needs until all quantities purchased have been used such as exchange should be within (2 weeks) after receipt of a written request from RMS.
- 4- The supplier should be committed to provide RMS with complete surgical application one set for each item on free of charge basis & to be delivered to RMS Main Medical Stores.
- 5- The supplier must furnish RMS with a guarantee stamped and legalized by the notary public equals to 115% of the total value of goods valid for (2 years) after acceptance of goods.
- 6- Certificate of origin & Free sale certificate should be submitted with the awarded items & should be legalized by the chamber of commerce in the country of origin & from Jordan Embassy or Jordan consulate if available
- 7- Goods must be freshly prepared on dispatch and must retain at least 2/3 of its shelf life when dispatch/delivered when is applicable. DRMS with this respect has the right to reject any item not in compliance with this term and impose the correspondent fines as per GHQ/Military procurement laws
- 8- Catalogues of the quoted items must be submitted along with the offers. Also samples should be submitted upon request from the purchasing committee. RMS with this respect reserves the right to reject any offer not in compliance with this term.
- 9- DRMS has the right to increase the awarded quantities by a percentage not exceeding 30% after final order notification required with the same prices, terms and conditions of the contract upon RMS written request
- 10- Prices should be fixed for (3 years) after receipt of final order.
- 11- Any defect or claim of any item used during surgical operation , it should be exchanged by within (one week)) after receipt of a written request from RMS
- 12- Pricing must include services of sale, shipment , transportation, delivery from port to site or to main medical stores .
- 13- Custom clearance of goods shall be the responsibility of the Jordanian Armed Forces (JAF) , however , suppliers shall bear all costs incurred by handling charges and any demurrage charges or extra expenses *incurred by the*

ports corporation (including expenses caused by delay in presentation the necessary documents for either clearing or transportation the goods to the required location mentioned in the final order , delivery note issuing charges , unloading charges, local shipping charges etc ...)

The supplier is also responsible for providing of all relevant shipping documents, together with the delivery order(s)

14- Training:

- a. Training courses or workshops for the offered items are usually conducted abroad, offers must include a certified training program at a reputable centre abroad recognized by the manufacturer for at least two neurosurgeon doctors; all costs inclusive, air tickets, ,boarding, commuting, accommodation (minimum 3 star hotel on full board basis) and any extra cost.
