التسلسل الشروط الخاصة

- 1 - GOODS MUST BE DELIVERED/DISPACHED UNDER THE SAME STORAGE CONDITIONS THAT COMPLY WITH THEIR NATURE.. STORAGE CONDITIONS MUST BE CLEARLY MENTIONED ON ALL PACKAGES AND RELATIVE DOCUMENTS
- 2 - DISPATCHED/DELIVERED GOODS MUST SHOW DESCRIPTION OF GOODS, LOT NO., EXPIRY DATE, MANUFACTURING DATE, STORAGE CONDITIONS, AND ANY OTHER NECESSARY INFORMATION ON THE INNER AND OUTER PACKS. WHERE MANUFACTURING DATE IS NOT APPLICABLE THEN IT SHOULD BE PROVIDED ON RELATIVE DOCUMENTS
- 3 - All goods are to be freshly prepared on dispatch/delivery & should have at least 2/3 of its shelf life upon receipt. Any item carrying less than 2/3 of its shelf upon receipt should be accompanied with a confirmation that you accept to replace any remaining unused quantities at your expenses after the expiry date. Said confirmation is subject to the approval of the director of the Royal Medical Services and will incur a fine, which will be decided later by DRMS according to the loss that this discrepancy with terms of the tender has caused.
- 4 - Sold to DRMS Should be printed or stamped or labeled on all outer and inner individual packs with unremovable ink.

- 5 - SAMPLES AND CATALOGUES OF THE QUOTED ITEMS MUST BE SUBMITTED ALONG WITH THE OFFERS FOR PURCHASING AND RECEIPT PURPOSES SHOWING THE SAME SERIAL NUMBER/ CAT NUMBER AS PER OUR TENDER DOCUMENTS SPECIFICATIONS .RMS WITH THIS RESERVES THE RIGHT TO REJECT OFFERS NOT IN COMPLIANCE WITH THIS TERM.
- 6 - FDA and/or CE certificates of the quoted items should be submitted along with offers.
- 7 - THE SUPPLIER OR HIS LOCAL AGENT MUST FURNISH RMS WITH A GUARANTEE STAMPED AND LEGALIZED BY THE NOTARY PUBLIC EQUALS TO 115% OF THE TOTAL VALUE OF GOODS VALID FOR (1YEARS) AFTER ACCEPTANCE OF GOODS.

- 9 - DRMS has the right to increase the quantities of the items requested by tender invitation by 30% after final order notification with same (prices, terms & conditions) of the contract upon our request .
- 10 - Pricing must include services of sale, shipment, transportation, delivery from port to site or to Main Medical Stores.

- 11 - Custom clearance of goods shall be the responsibility of the Jordanian Armed Forces (JAF), however, suppliers shall bear all costs incurred by handling charges and any demurrage charges or extra expenses incurred by the port's corporation or QAIA (including expenses caused by delay in presenting the necessary shipment documents for either clearing or transporting the goods to the required location mentioned in the final order, delivery note issuing charges, unloading charges, local shipping charges, etc.). The supplier is also responsible for providing of all relevant shipping documents ,together with the delivery order(s).
- 12 - ANY NEW COMPANY MANUFACTURES MACHINES WITH A SIMILAR PRINCIPAL OF THAT OF THE REQUESTED SYSTEM (NEGATIVE PRESSURE WOUND THERAPY) IS INVITED TO PARTICIPATE IN THIS TENDER AND IS ASKED TO SUBMITT MACHINES ON FREE OF CHARGE BASIS AGAINST THE AWARDED CONSUMABLES .
- 13 - Two years full warranty for the F.O.C. machines starting date of installation including spare parts & Labor.The warranty must be accompanied by a bank guarantee equal to 5% of the total estimated value of the F.O.C machines valid for two year being the warranty period
- 14 - SPARE PARTS MUST BE AVAILABLE FOR A MINIMUM PERIOD OF 10 YEARS FRM DATE OF INSTALLATION AND COMMISSIONING FOR THE F.O.C. MACHINES

16	- A COMPREHENSIVE PRICED LIST OF SPARE PARTS FOR THE F.O. C. MACHINES VALID FOR FIVE YEARS SHOULD BE SUBMITTED UPON PURCHASE.
17	- ADEQUATE ON SITE USER TRAINING & SERVICE TRAINING FOR THE F.O.C.MACHINES.
18	- "A- TWO ORIGINAL COPIES OF FULL OPERATOR MANUAL MUST BE PROVIDED ON FREE OF CHARGE BASIS WITH THE F.O.C . MACHINES. B- TWO ORIGINAL COPIES OF FULL SERVICE MANUAL INCLUDING SPARE PARTS LIST MUST BE PROVIDED ON FREE OF CHARGE BASIS WITH THE F.O.C . MACHINES
19	- SHIPMENTS/ DELIVERIES: TWO EQUAL SHIPMENTS/DELIVERIES (6-7) MONTHS APARTS
20	- COUNTRY OF ORIGIN: THE COUNTRY OF ORIGIN OF THE MAIN PART(S) OF THE SYSTEM MUST BE ONE OF THE FOLLOWING : USA, CANADA, JAPAN , UK, SWEDEN, FINLAND, DENMARK, SWITZERLAND, BELGIUM, GERMANY, FRANCE, NETHERLANDS, SPAIN, NORWAY, ITALY, IRELAND, AUSTRIA, NEW ZEALAND, AUSTRALIA& CZECH REPUBLIC.
21	- Goods should be previously evaluated and approved or purchased by DRMS tenders, RMS approval certificates (for previously approved (items) should be submitted along with offers
