- Sterile items and those which need certain storage conditions must show description of goods, size number, manufacturing date, expiry date, batch no., storage conditions and such items should retain at least 2/3 of its shelf life upon receipt. The remaining items must show description of goods, size number, manufacturing date, batch number and any other necessary information on the inner and outer packs.
