- 1 - GOODS MUST BE DISPATCHED/DELIVERED UNDER THE SAME STORAGE CONDITIONS THAT COMPLY WITH THEIR NATURE. STORAGE CONDITIONS MUST BE CLEARLY INDICATED ON ALL PACKAGES AND RELATIVE DOCUMENTS
- 2 - DESCRIPTION OF GOODS, MANUFACTURING DATE, LOT NO. AND EXPIRY DATE MUST BE CLEARLY INDICATED ON ALL PACKAGES
- 3 - DELIVERY TO BE IN TWO EQUAL CONSIGNMENT (7-8) MONTHS APART
- 4 - THE DELIVERED GOODS MUST BE STAMPED, PRINTED OR LABELLED:- "SOLD TO DRMS". WITH DURABLE INK
- 5 - ALL PARCELS, PACKAGES AND RELATIVE DOCUMENTS TO BE MARKED:-

- 6 - ALL GOODS ARE TO BE FRESHLY PREPARED ON DISPATCH & SHOULD HAVE AT LEAST 2/3 OF ITS SHELF LIFE UPON RECEIPT. ANY ITEM CARRYING LESS THAN 2/3 OF ITS SHELF UPON RECEIPT SHOULD BE ACCOMPANIED WITH A CONFIRMATION THAT YOU ACCEPT TO REPLACE ANY REMAINING UNUSED QUANTITIES AT YOUR EXPENSES AFTER THE EXPIRY DATE . SAID CONFIRMATION IS SUBJECT TO THE APPROVAL OF THE DIRECTOR OF THE ROYAL MEDICAL SERVICES AND WILL INCUR A FINE , WHICH WILL BE DECIDED LATER BY DRMS ACCORDING TO THE LOSS THAT THIS DISCREPANCY WITH TERMS OF THE TENDER HAS CAUSED
- 7 - Custom clearance of goods shall be the responsibility of the Jordanian Armed Forces (JAF), however, suppliers shall bear all costs incurred by handling charges and any demurrage charges or extra expenses incurred by the port's corporation or QAIA (including expenses caused by delay in presenting the necessary shipment documents for either clearing or transporting the goods to the required location mentioned in the final order, delivery note issuing charges, unloading charges, local shipping charges, etc.) .The supplier is also responsible for providing of all relevant shipping documents ,together with the delivery order(s).
- 8 - Pricing must include services of sale, shipment, transportation, delivery from port to site or to Main Medical Stores.

- 9 - THE QUALITY OF ITEMS SHOULD BE ACCORDING TO ACCEPTED INTERNATIONAL STANDARDS I.E (FDA, CE, U.S.PHARMACOPOEIA, EUROPEAN PHARMACOPOEIA, B.P, T.U.V. OR EQ. STANDARD CERTIFICATES) SHOULD BE ACCOMPANIED WITH THE OFFERS.
- 10 - DRMS HAS THE RIGHT TO INCREASE THE AWARDED QUANTITIES BY A PERCENTAGE NOT EXCEEDING 30% AFTER FINAL ORDER NOTIFICATION WITH THE SAME PRICES , TERMS & CONDITIONS
- 11 - IN CASE OF ANY CARTRIDGE FAILURE THAT MAY CAUSE ANY DAMAGE/BREAKDOWN TO THE STERILIZATION UNIT, DRMS RESERVES THE RIGHT TO CLAIM THE TOTAL AMOUNT OF ALL DAMAGED PARTS UP TO THE TOTAL AMOUNT OF STERILIZATION UNIT
- 12 - ANY CARTRIDGE THAT FAILS TO BE PUNCHED OR SHOWS ANY MANUFACTURING DEFECT THAT MAY LEAD TO MALFUNCTION OF THE EQUIPMENT SHOULD BE REPLACED WITHIN 48 HOURS AFTER WRITTEN NOTIFICATION FROM DRMS
- 13 - THE SUPPLIER OR HIS LOCAL AGENT MUST FURNISH THE RMS WITH AGUARANTEE STAMPED AND LEGALIZED BY THE NOTARY PUBLIC EQUALS TO 115% OF THE TOTAL VALUE OF THE GOODS VALID FOR (2 YEARS) AFTER ACCEPTANCE OF GOODS
- 14 - SHELF LIFE OF GOODS TO BE MINIMUM FIVE YEARS
