الشروط الخاصة التسلسل

1	- Goods must be dispatched/delivered under the same storage conditions that comply with their nature.
2	- Storage conditions as well as description of goods, manufacturing date, lot no, and expiry date must be clearly indicated on all packages and relative documents .
3	- All goods are to be freshly prepared on dispatch & should have at least 2/3 of its shelf life upon receipt . Any item carrying less than 2/3 of its shelf upon receipt should be accompanied with a confirmation that you accept to replace any remaining unused quantities at your expenses after the expiry date . Said confirmation is subject to the approval of the director of the Royal Medical Services and will incur a fine, which will be decided later by DRMS according to the loss that this discrepancy with terms of the tender has caused.
4	- (Sold to DRMS) Should be printed or stamped or labeled on all outer and inner individual packs with unremovable ink.
5	- Samples and catalogues of the quoted items should be submitted along with the offers for purchasing and receipt purposes showing the same serial number/cat. number as per our tender documents specifications. RMS with this reserves the right to reject offers not in compliance with this terms.
6	- All goods should be FDA AND/OR CE approved

- 7 - THE SUPPLIER OR HIS LOCAL AGENT MUST FURNISH RMS WITH A GUARANTEE STAMPED AND LEGALIZED BY THE NOTARY PUBLIC EQUALS TO 115% OF THE TOTAL VALUE OF GOODS VALID FOR (1 YEAR) AFTER ACCEPTANCE OF GOODS.
- 8 - All parcels, packages and any relative documents to be marked : DRMS/TENDER No. P18-2017-4 GHQ/JORDAN ARMED FORCES AMMAN, JORDAN
- 9 - All items should to be delivered in one Consignment.
- 10 - Custom clearance of goods shall be the responsibility of the Jordan Armed Forces (JAF); however, suppliers shall bear all costs incurred by handling charges and any demurrage or extra expenses incurred by the port's corporation or QAIA (including expenses caused by delay in presenting the necessary shipment documents for either clearing or transporting the goods to the required location mentioned in the final order, delivery note issuing charges, unloading charges, local shipping charges etc.). The supplier is also responsible for providing of all relevant shipping documents, together with the delivery order(s)
- 11 - Pricing must include services of sale, shipment, transportation, delivery from port to main medical stores.
- 12 - Goods should be previously evaluated and approved or purchased by DRMS tenders, RMS approval certificates for previously approved items should be submitted along with offers .

- 13 - DRMS HAS THE RIGHT TO INCREASE THE AWARDED QUANTITIES BY A PERCENTAGE NOT EXCEEDING 30% AFTER FINAL ORDER NOTIFICATION WITH THE SAME PRICES, TERMS & CONDCTIONS.
- 14 - Where Applicable, The acceptance of the goods is subjected to the approval of the Quality assurance laboratory of the JFDA.
- a. all inspection charges will be on local agent expenses .
- b. any rejected lot should be returned back to the supplier at his own expanses and/or compensation should be delivered or effected in a period not exceeding (30) days from the written notification by the directorate of the royal medical services.
