الشروط الخاصة التسلسل

- 1 - Goods must be dispatched/delivered under the same storage conditions that comply with their nature.
- 2 - Dispatched/delivered goods must show description of goods, expiry date, lot no. Storage conditions and any other nessecary information. Where manufacturing date is not applicable, then shelf life of products offered should be provided.
- 3 - All goods are to be freshly prepared on dispatch & should have at least 2/3 of its shelf life upon receipt . Any item carrying less than 2/3 of its shelf upon receipt should be accompanied with a confirmation that you accept to replace any remaining unused quantities at your expenses after the expiry date . Said confirmation is subject to the approval of the director of the Royal Medical Services and will incur a fine, which will be decided later by DRMS according to the loss that this discrepancy with terms of the tender has caused.
- 4 - The quality of the items should be according to accepted international standards I.E (FDA,CE,TUV,US.Pharmacopoeia, European Pharmacopoeia,B.P Or Equivalent Standards),Accompanied with Quality Certificates .
- 5 - Samples of the quoted items must be submitted along with the offers for evaluation purposes, showing the same serial No./Stock No.as per our tender documents specifications.

- 6 - All items should be shipped in (4) equal shipments (4-5) months apart. First shipment is to be within one month from date of final order.
- 7 - All the Quality Assurance Tests where is necessary will be at the bidders expenses at the value of 0.7% of the item in question .
- 8 - Sold to DRMS Should be printed or stamped or labeled on all outer and inner individual packs with unremovable ink , either by the company or by local agent
- 9 - All parcels, packages and related documents to be marked :-

- 10 - DRMS has the right to increase the awarded quantities by a percentage not exceeding 30% after final order notification with the same prices, terms & conditions.
- 11 - After arrival to Jordan , DRMS is not responsible for any handling charges for goods (like charges for issuing delivery note vouchers , unloading charges , local shipping agent's charges, Downloading charges in Main Medical Stores.).
- 12 - GHQ/RMS are not responsible for any demurrage charges and other charges incurred by the port corporation caused by delay in presenting all necessary shipping documents for clearing the goods .

- 13 - THE SUPPLIER OR HIS LOCAL AGENT MUST FURNISH RMS WITH A GUARANTEE STAMPED AND LEGALIZED BY THE NOTARY PUBLIC EQUALS TO 115% OF THE TOTAL VALUE OF GOODS VALID FOR (2 YEARS) AFTER ACCEPTANCE OF GOODS.
- 14 - a.The acceptance of goods in subjected to the approval of the quality assurance laboratory of the JFDA, all inspection charges will be on local agent expences
b. any rejected lot should be returned back to the supplier at this own expense and replacement and/or compensation should be delivesred or effected in a period not exceeding 30 days from the written notification by the DIRECTORATE of the ROYAL MEDICAL SERVICES.
- 15 - Custom clearance of goods shall be the responsibility of the Jordanian Armed Forces (JAF),how ever, suppliers shall bear all costs incurred by handling charges and any demurrage charges or extra expenses incurred by the port's corporation or QAIA (including expenses caused by delay in presenting the necessary shipment documents for either clearing or transporting the goods to the required location mentioned in the final order, delivery note issuing charges, unloading charges, local shipping charges, Downloading charges-in Main Medical Stores) .The supplier is also responsible for providing af all relevant shipping documents ,together with the delivery orders.
